- Fence at Eleanor Lane. The information from councillors is that the works will start to allow this to re-open.
- Lights are out at Knockamillie Terrace.

- Dot said rats have again been seen and commented the high costs of calling the council out will put people off.
- Dot also asked why taxi drivers do not need to wear masks or have a plastic screen in their cabs?
- Michael, Kyle and Roy will install the signs on the grass area near McLennan Cottages within the next few weeks.
- Michael reported that after correspondence with Melissa Stewart of Argyll &
  Bute Council, she had agreed that electronic banking could be carried out by a
  single person provided there was prior authorisation. Joyce will speak to the
  bank about this and the internal SCCC procedure for electronic banking will be
  as follows:
  - The treasurer will request email authorisation of any payment to be made, in advance, by a member of SCCC.
  - That authorisation will be filed with the invoice or other voucher so that when the accounts are examined it can be seen that there was prior authorisation of the payment.
  - The treasurer is then authorised to make the electronic banking payment by his or her self, ie single authorisation electronically provided there is a pre-authorisation by another SCCC member.
