Hydro Funds

After discussion is was agreed to wait till next year's allocation is received to allow larger grants to be applied for in 2023.

Education Service

- After discussion on the proposed changes to school management, now abandoned, and the email dated 23 August 2022 from Iona Community Council, it was agreed to write to Pippa Milne, cc Jenni Minto MSP, Iona CC and others supporting Iona CC in their request for an independent inquiry into the matter.
- The meeting discussed the paper circulated earlier which summarised the concerns of parents in the area. This paper outlined the wider context, ie of guidance issued to councils and the proposed changes to the Gender Recognition Act currently going through the Scottish Parliament. It was agreed unanimously that a letter should go to the council chief executive, cc the council leader Robin Currie, expressing concern at the lack of parental involvement and highlighting the fact that as the guidance was both non statutory and controversial, the implementation of this within Argyll & Bute should be a policy matter for elected members to determine at full council.

It was noted that there was no support from anyone present to the key changes proposed to the Gender Recognition Act, ie reduction in age, removal of psychiatric and medical procedures, introduction of "self ID" and the reduction in time living "in line" with your new gender from 2 years to 3 months.

Ground owned by ACHA

It was discussed at length and deferred to the December meeting. It was noted that Inspiring Innellan has carried out a huge amount very valuable work within Innellan. It was hoped this would be recognised formally by Argyll & Bute Council. Discussions will continue to see if a solution can be agreed before the December meeting.
