### 8. Matters arising

- Progress was being made towards a better ferry timetable to meet the trains and West Coast Motors were in the process of amending the bus timetable. It was hoped to get the amendments in place soon.
- Bollards at Castle Toward: actions in place to fix this.
- Pingo Bus: Alistair raised the costs of the Pingo bus and related this to the costs of repairs and rental to the food bank. FOI requests had shown there was a significant loss on the Pingo bus. Concerns were expressed at the fact Pingo buses often operated around the same time as the service bus. The wider issue was that people wanted value for money from the council. Councillors agreed to discuss the costs with West Coast Motors and the council.

Questions had been asked of TS about why it took 13 years before they acted on the unreliability issue.

AMM organised for November, members to be notified. EPOS training will be continued in January. Grant funds from HIE will end in March 2025. In discussions with the Lottery over continued grant funding for the project officer. Thanks to Ian for his efforts.
