None of this is helped though, by having some council officers that refuse to consult with our community, and who claim work has been completed in items we have raised, even though nothing has happened. Repeated requests for officers to attend our meetings have been ignored.

The 20mph lights at Toward School have not functioned properly in all the time they have been there, despite many complaints having been made. This is compromising the safety of the children and failure to address this is putting them at risk.

With the help of the Community Council we have now set up the South Cowal Trust, it initially was done so that we could become part of Cowal Community Energy, but now it

10 Pavement Parking

11 Overflowing sewage opposite Trinity Lane

12 Star Garage

Jan told the meeting of the issue which again needs raised with the council, as does the wall of the old Royal Hotel which appears in danger of collapse.

13 Sandy Beach Toilets

Inspiring Innellan was asked to paint the building. No more payment meters are planned in A&B. An asset transfer was a potential long term solution.

14 AOCB

- Alan noted that Cowal Community Energy had failed in the bid to do the repowering
 of the Glendaruel windfarm, however buying a share may still be an option. There
 was significant potential income from the StatKraft proposal above Dunoon, if
 agreed by the Scottish Government.
- There was discussion on the continuing issues with the passenger ferry and related issues.
- Fire hydrants in Wyndham Rd/No Campbell Rd have been tarred over.
- There was a strong smell of chlorine in drinking water. Michael will contact Scottish Water about this and about benzine from boats in Loch Eck.
- Thanks from Jan re blocked drain at Wyndham Rd. Drain at Knockamillie Rd is still needing fixed.
- It was agreed that the council could benefit from an asset transfer department which other councils have.
- Hydro Funds for this year have not yet been received. Michael will contact Lisa re the grant given to the school as part of the previous awards.
